

**SUMMARY ANNUAL REPORT FOR
SOUTH EAST PERSONNEL LEASING WELFARE BENEFITS PLAN**

This is a summary of the annual report of the SOUTH EAST PERSONNEL LEASING WELFARE BENEFITS PLAN, a health, life insurance, dental, vision, temporary disability, long-term disability and death benefits plan (Employer Identification Number 59-3298197, Plan Number 502), for the plan year 04/01/2021 through 03/31/2022. The annual report has been filed with the Employee Benefits Security Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

Insurance Information

The plan has insurance contracts with BLUE CROSS AND BLUE SHIELD OF FLORIDA, THE LINCOLN NATIONAL LIFE INSURANCE COMPANY, The Lincoln National Life Insurance Company, The Lincoln National Insurance Company, METROPOLITAN LIFE INSURANCE COMPANY, SAFEGUARD HEALTH PLANS, INC., A FLORIDA CORPORATION, ALLSTATE BENEFITS, Allstate Benefits, AFLAC, TRANSAMERICA LIFE INSURANCE COMPANY, TRANSAMERICA LIFE INSURANCE COMPANY, SAFEGUARD HEALTH PLANS, INC., A CALIFORNIA CORPORATION and PROFESSIONAL INSURANCE COMPANY to pay certain Health, Prescription drug, PPO contract, Indemnity Contract, Life insurance, ACCIDENTAL DEATH & DISMEMBERMENT, ACCIDENTAL DEATH & DISMEMBERMENT, Temporary disability, Long-term disability, Dental, Vision, HMO contract, Accident, Cancer, Critical Illness, Disability, Hospital Indemnity, Heart/Stroke, DISABILITY-EMPLOYEE EXPENSES, CI, ACCIDENT, CANCER claims incurred under the terms of the plan. The total premiums paid for the plan year ending 03/31/2022 were \$12,726,791.

Because they are so called "experience-rated" contracts, the premium costs are affected by, among other things, the number and size of claims. Of the total insurance premiums paid for the plan year ending 03/31/2022, the premiums paid under such "experience-rated" contracts were \$11,402,876 and the total of all benefit claims paid under these experience-rated contracts during the plan year was \$9,429,113.
